SUMMARY OF NATURAL ENGLAND'S ADVICE

No Objection Subject to Mitigation

Consultation under Reg 63 (3) of The Conservation of Habitats and Species Regulations 2017.

The submitted nutrient statement concludes that after the Somerton WWTW improvements take place in 2025 the scheme would result in the discharge of an additional 0.18kg TP yr to the River Parrett hydrological catchment of the Somerset Levels and Moors Ramsar site which will be offset through acquisition of phosphorus credits from the Woodrow Farm approved phosphorus mitigation scheme. I can confirm Natural England accepts the nutrient budget for the scheme and the proposed approach to delivering phosphorus mitigation. On this basis Natural England agrees with the submitted sHRA.

The authority should be mindful of the need to secure the mitigation measures including:


- Ensuring that the proposed new development is required to limit water use to 110 l per person per day.
- Ensuring the requisite phosphorus credits are secured by any permission.
